The Georgia Environmental Protection Division (EPD) has reviewed the February 2018 Voluntary Remediation Program (VRP) Compliance Status Report (CSR), submitted to EPD by Conagra Foods, Inc., pursuant to the Georgia Voluntary Remediation Program Act (the Act), O.C.G.A. 12-8-100. We also reviewed VRP Semiannual Reports 3 and 4. Based upon EPD's review of these documents and information in its files, EPD concurs with your revised Certification of Compliance, submitted to us via email on September 24, 2018, that the site is in compliance with Type 1 risk reduction standards (RRSs) for soil for tax parcels M022A 004, M022A 004A, M022A 005, and M022A 002C, Type 1 RRSs for groundwater for tax parcel M022A 002C, and Type 5 RRSs for groundwater for tax parcels M022A 004, M022A 004A, and M022A 005. In addition, EPD is not requiring any further groundwater monitoring at the site. Therefore, you may properly abandon all monitoring wells at the site in accordance with the Georgia Water Well Standards Act (OCGA 12-5-120).

In order to remove this site from the Hazardous Site Inventory (HSI), EPD requires that Conagra Foods, Inc., execute the proposed Uniform Environmental Covenants (UECs) for tax parcels M022A 004, M022A 004A, and M022A 005. Revisions to the draft UECs should be made in accordance with telephone and email correspondence between EPD and Conagra's consultant, AMEC Foster Wheeler. The revised UECs should be submitted to EPD for final review and approval prior to distribution for signatures. Please submit the draft UECs to EPD by December 21, 2018.
