### NOTICE OF STAKEHOLDER MEETING ON THE PROPOSED REISSUANCE OF NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) GENERAL PERMIT FOR DISCHARGES ASSOCIATED WITH CONSTRUCTION ACTIVITY FOR COMMON DEVELOPMENT CONSTRUCTION PROJECTS TO WATERS OF THE STATE OF GEORGIA.

The Georgia Environmental Protection Division (Division), Watershed Protection Branch, is conducting a stakeholder meeting to discuss the reissuance of General NPDES Permit No. GAR100003, authorizing stormwater discharges associated with construction activity for common development construction projects to waters of the State of Georgia. The purpose of the meeting is to inform and to provide stakeholders with the opportunity to request clarification on the proposed permit changes. At the meeting, anyone may offer comments. The Division will listen to comments and address stakeholder questions during the meeting. However, lengthy comments or statements should be submitted in writing. The Division will be hosting the stakeholder meeting via Zoom. Zoom is a free web conferencing platform that also allows participation by phone.
