RE: Covington November 1 -23, 2019 Sampling Results for Ethylene Oxide

Samples of Ethylene Oxide (EtO) were collected during the period of November 1 - 23, 2019 by the Ambient Monitoring Program in the Covington area to characterize the EtO concentration. Each of the samples were sent to Eastern Research Group (ERG) for analysis. The samples listed as X indicate that the sample was not collected properly. The sample listed as QA is a sample taken side by side during the same time period to compare the precision of the measurement. The Qualifier code of "LK" was given by ERG to indicate that the sample may be biased high. The Qualifier code of "2" was given to indicate that the collection deviated from established procedures, but the integrity of the sample was not compromised.
