The Georgia Environmental Protection Division (EPD) has reviewed the documents for the above-referenced site that were submitted pursuant to the Georgia Voluntary Remediation Program Act (Act) and the Georgia Rules for Hazardous Site Response (Rules). documents include the Compliance Status Report (CSR) dated June 6, 2011, the Response to EPD VRP Comments dated May 30, 2013, and the 1st, 2nd, and 3rd Annual Groundwater Monitoring and Maintenance Reports dated January 15, 2014, January 26, 2015, and March 10, 2016, respectively. EPD responded to these documents in previous correspondence. EPD has determined that comments related to the CSR have been addressed and the groundwater monitoring requirement has been satisfied. EPD has also reviewed the certification of compliance dated July 7, 2016 and the Uniform Environmental Covenant (UEC) submitted on July 19, 2016. Based on these documents, EPD concurs with the July 7, 2016 certification of compliance that this site is in compliance with Type 1 risk reduction standards (RRS) for soil and Type 4 RRS for groundwater with institutional controls restricting the use of groundwater in accordance with the provisions, purposes, standards, and policies of the Voluntary Remediation Program. Therefore, I am reclassifying this site as a Class III site, and I am removing it from the Hazardous Site Inventory in accordance with §391-3-19-.05(4)(b) of the Rules and §12-8-107(f) of the Act as of the date of this letter. As required by §391-3-19-.06(5)(f) of the Rules, a public notice announcing this determination shall be published in the Rockdale Citizen no sooner than thirty (30) days after the issuance of this letter.

Pursuant to *Activity and/or Use Limitation* Condition #3 of the UEC, please submit the Annual Certification Form (Exhibit C of the UEC) to EPD by July 31 each year beginning on July 31, 2017.
