The Georgia Environmental Protection Division (EPD) has reviewed the following: (1) the Voluntary Remediation Program (VRP) Compliance Status Report (CSR) dated April 7, 2015; (2) the Voluntary Investigation and Remediation Plan Semiannual Status Report dated December 19, 2014; (3) the VRP Monitoring Plan; and (4) two Uniform Environmental Covenants (UECs) (one UEC for the source property, parcel # 18-343-13-002, and one executed by the adjacent property owner, parcel #18-343-13-005) executed on May 27, 2014 for the above referenced site. Based on these documents, EPD has determined that the CSR is complete and concurs with your certification of compliance that soil is in compliance with Type 5 risk reduction standards (RRS). Furthermore, I have determined that a release to groundwater exceeding a reportable quantity did not exist at the time of enrollment in the VRP. Therefore, I am reclassifying this site as a Class III site and removing it from the Hazardous Site Inventory in accordance with §391-3-19-.05(4)(b) of the Rules of Hazardous Site Response (the Rules) and §12-8-107(f) and (g)(2) of the Georgia Voluntary Remediation Program Act (the Act) as of the date of this letter. As required by §391-3-19-.06(5)(f) of the Rules, a public notice announcing this determination shall be published in *The Champion Newspaper*.

Pursuant to *Activity and/ or Use Limitation* Condition #4 of the May 27, 2014 UECs, please submit the Annual Type 5 Property Evaluation and Compliance Forms to EPD by February 10th each year beginning on February 10, 2016. In addition, EPD anticipates receipt of the first groundwater monitoring report on February 10, 2016 in accordance with the approved VRP Monitoring Plan.
