Notice is hereby given that the State of Georgia has completed the compilation of a list of waters in accordance with Section 303(d) of the Clean Water Act. The listing was produced by the Georgia Environmental Protection Division in accordance with U. S. Environmental Protection Agency rules and guidelines.

In addition, the package may be reviewed by appointment only during normal business hours 8:00 a.m. to 4:30 p.m., Monday through Friday (except official State holidays or EPD office closures) at the following location: Environmental Protection Division, Watershed Protection Branch, 200 Piedmont Ave. S.W., Suite 418, Atlanta, Georgia 30334, (404) 463-1511. However, during the Governor's Shelter in Place Executive Order dated April 2, 2020, the documents will not be available for in person review.

A single copy of the draft 2020 305(b)/303(d) List package is available by written or phone request to the Georgia Environmental Protection Division. Please direct requests to Ms. Arnettia Murphy at the address or phone number given above. If additional copies are requested, a copying charge of 10 cents per page will be assessed.

Written comments are welcomed. To ensure their consideration, written comments should be received on or before 4:30 p.m. June 4, 2020.
