Samples of Ethylene Oxide (EtO) were collected on April 09, 2020 in the south Fulton area to characterize the EtO concentrations. The samples were sent to Eastern Research Group (ERG) for analysis. The Qualifier code of "2" is applied to samples to indicate that the collection deviated from established procedures, but the integrity of the sample was not compromised.

Please note that ERG is now providing values for levels below the detection limit.

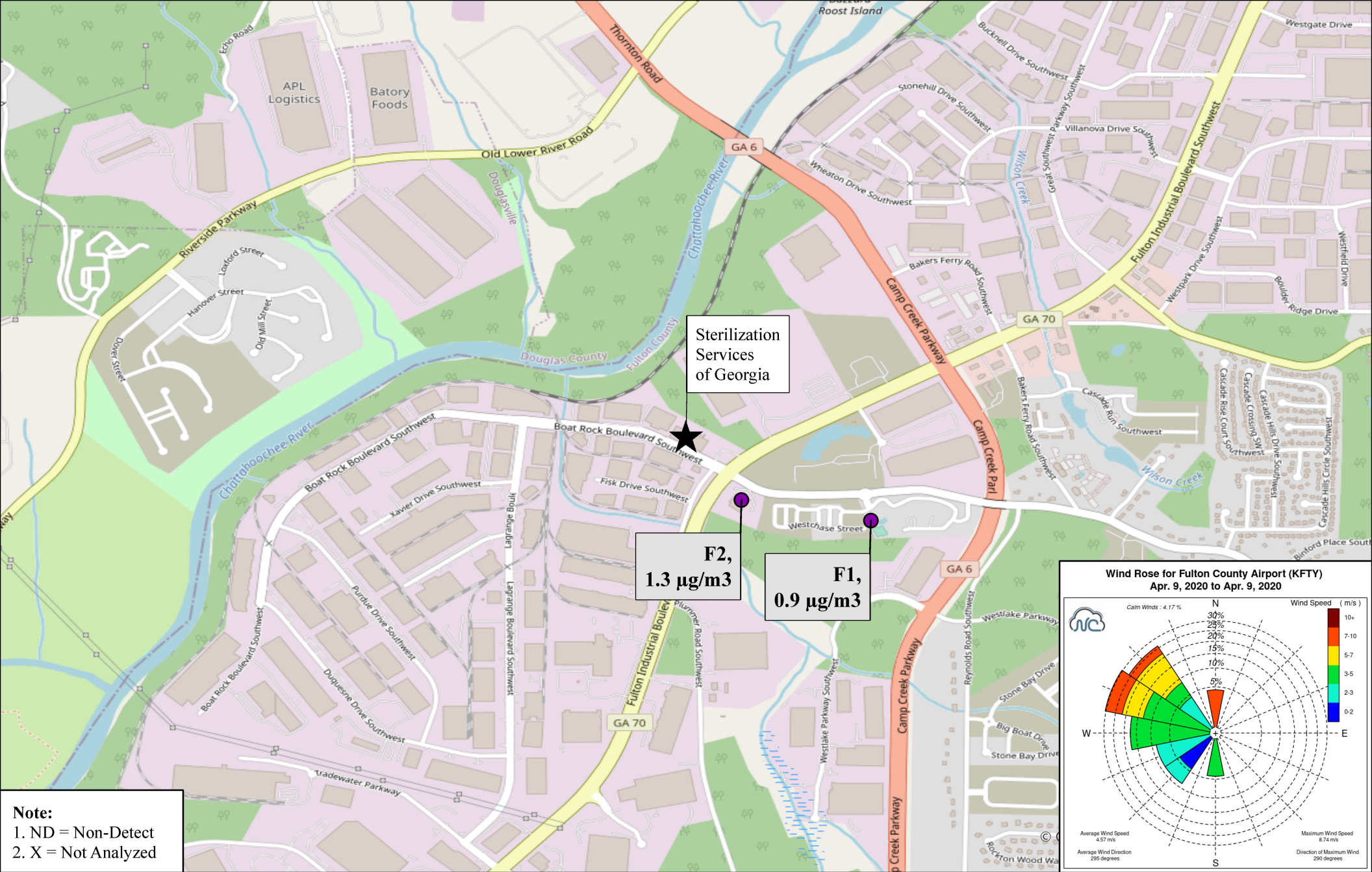

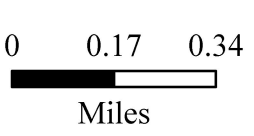


Sterilization Services of Georgia
