As requested, we are enclosing revised recommended Industrial User (IU) local limits for the Henry County Water Authority (HCWA) for facilities that discharge to the Indian Creek Water Reclamation Facility (WRF). This revision maintains the mercury limit at 0.0078 mg/L as recommended by EPD.

The total suspended solids (TSS) limit in the final Indian Creek WRF permit of 10 mg/L does not change the HCWA local limit for TSS, which is more stringent than required based on a limit of 5 mg/L assumed in calculations.
