

Georgia Asbestos Contractor Licensing – Just the Basic Facts

Asbestos Project Requirements

If you are a contractor who performs **abatement** (removal) of 10 square feet or 10 linear feet or more of friable asbestos-containing material (ACM) you must be a **Georgia-Licensed Asbestos Abatement Contractor** AND submit a Project Notification form for each project through GEOS.

- Complete an application: “Asbestos New Contractor”
- Assign a Primary Agent to complete training and document supervised projects
- Attend training: Initial Supervisor training course of 40 hours from a Georgia-Accredited training provider with Georgia EPD or EPA Direct Approval (see NDAAC list)
 - ◊ Initial training must have been completed within 48 months
 - ◊ Refresher training annually
- Document Experience: Serve as the onsite supervisor for 3 notified projects involving friable materials
- Provide: A written Standard Operating Procedure (SOP) describing work practices and compliance with regulations; Disclosure of previous enforcement, if applicable; Notarized applicant letter
- Fee of \$100/ 3 years



- Complete an application: “Asbestos Renewal Contractor”
- Assign a Primary Agent, if applicable
- Attend training: Refresher Supervisor training course of 8 hours from a Georgia-Accredited training provider with Georgia EPD or EPA Direct Approval (see NDAAC list)
 - ◊ The annual refresher course must be completed within 12 months of completion of previous training
- Provide: Disclosure of previous enforcement, if applicable and an updated SOP, if applicable
- Fee of \$100/ 3 years
- Submit the renewal application at least 30 days prior to the expiration date of the previous license

Asbestos Activities

Georgia's Asbestos Regulations include the GA Asbestos Removal and Encapsulation Rule, Chapter 391-3-14, the GA Solid Waste Rule, Chapter 391-3-4-.04, and the GA Air Quality Control Rule, Chapter 391-3-1. The Lead-Based Paint and Asbestos Program is responsible for enforcing the State's Asbestos rule requirements, including: reviewing project notifications; licensing the asbestos removal company and their Primary Agent; conducting outreach and education; and developing technical guidance. If you or your firm perform renovation or repair work, including ASBESTOS ABATEMENT, on target housing (built before 1978) OR child-occupied facilities (built before 1978), then you and your firm are required to become a GA-Certified RRP Firm & Renovator to “advertise to, agree to or perform” work or services on these types of facilities.
