## NOTICE OF PUBLIC HEARING AND PROPOSED AMENDMENTS TO GEORGIA'S RULES FOR ENHANCED INSPECTION AND MAINTENANCE CHAPTER 391-3-20

## TO ALL INTERESTED PERSONS AND PARTIES:

Notice is hereby given that, pursuant to the authority set forth below, the Environmental Protection Division (hereinafter, "EPD") of the Georgia Department of Natural Resources proposes Amendments to Georgia's Rules for Enhanced Inspection and Maintenance, Chapter 391-3-20 (hereinafter, "the proposed Inspection and Maintenance Rule Amendments"). The Director of EPD certifies that the revisions to rules 391-3-20-.01, 391-3-20-.04, 391-3-20-.05, 391-3-20-.09, 391-3-20-.10, 391-3-20-.11, 391-3-20-.13, 391-3-20-.15, 391-3-20-.17 and 391-3-20-.22 are required to exercise authority approved and/or delegated by the U.S. Environmental Protection Agency to implement Section 182 of the Federal Clean Air Act. The proposed Inspection and Maintenance Rule Amendments are described below:

**Rule 391-3-20-.01, "Definitions,"** is being amended to update the definitions by revision as necessary. Rule 391-3-20-.01 will be submitted as a SIP revision to EPA.

**Rule 391-3-20-.04, "Emission Inspection Procedures,"** is being amended to remove an outdated requirement. Rule 391-3-20-.04 will be submitted as a SIP revision to EPA.

Rule 391-3-20-.05, "Emission Standards," is being amended to revise language and reorder subparagraphs. Rule 391-3-20-.05 will be submitted as a SIP revision to EPA.

Rule 391-3-20-.09, "Inspection Station Requirements," is being amended to remove outdated requirements, update terminology, and add description to the requirements. Rule 391-3-20-.09 will be submitted as a SIP revision to EPA.

**Rule 391-3-20-.10, "Certificates of Authorization,"** is being amended to clarify a requirement. Rule 391-3-20-.10 will be submitted as a SIP revision to EPA.

Rule 391-3-20-.11, "Inspector Qualifications and Certification," is being amended to update terminology and clarify language. Rule 391-3-20-.11 will be submitted as a SIP revision to EPA.

Rule 391-3-20-.13, "Certificate of Emission Inspection," is being amended to update requirements. Rule 391-3-20-.13 will be submitted as a SIP revision to EPA.

**Rule 391-3-20-.15, "Repairs and Retests,"** is being amended to remove outdated requirements. Rule 391-3-20-.15 will be submitted as a SIP revision to EPA.

**Rule 391-3-20-.17**, "Waivers," is being amended to update terminology. Rule 391-3-20-.17 will be submitted as a SIP revision to EPA.

**Rule 391-3-20-.22, "Enforcement,"** is being amended to update terminology. Rule 391-3-20-.22 will be submitted as a SIP revision to EPA.
