Notice is hereby given that, pursuant to the authority set forth below, the Environmental Protection Division (hereinafter, "EPD") of the Georgia Department of Natural Resources proposes Amendments to the Georgia Rules for Lead-Based Paint Hazard Management, Chapter 391-3-24 (hereinafter, "the proposed Lead Rule Amendments").

EPD proposes the Lead Rule Amendments as described below:

Rule 391-3-24-.03, "Definitions," is being revised to update the definitions of "Clearance Levels" and "Dust-lead hazard" to ensure consistency between State and Federal programs.

Rule 391-3-24-.06, "Standards for Conducting Lead-Based Paint Activities," is being revised to adopt the updated Federal lead-based paint dust hazard levels for lead abatement into the Georgia Rules and to ensure consistency between State and Federal requirements

Rule 391-3-24-.07, "Lead Clearance Levels," to adopt the updated Federal dust-lead clearance levels for lead abatement into the Georgia Rules and to ensure consistency between State and Federal requirements.
