**NOTICE OF PUBLIC HEARING AND PROPOSED AMENDMENTS  
TO GEORGIA'S RULES FOR LEAD-BASED PAINT HAZARD MANAGEMENT  
CHAPTER 391-3-24**

**TO ALL INTERESTED PERSONS AND PARTIES:**

Notice is hereby given that, pursuant to the authority set forth below, the Environmental Protection Division (hereinafter, "EPD") of the Georgia Department of Natural Resources proposes Amendments to the Georgia Rules for Lead-Based Paint Hazard Management, Chapter 391-3-24 (hereinafter, "the proposed Lead Rule Amendments").

EPD proposes the Lead Rule Amendments as described below:

**Rule 391-3-24-.03, "Definitions,"** is being revised to update the definitions of "Clearance Levels" and "Dust-lead hazard" to ensure consistency between State and Federal programs.

**Rule 391-3-24-.06, "Standards for Conducting Lead-Based Paint Activities,"** is being revised to adopt the updated Federal lead-based paint dust hazard levels for lead abatement into the Georgia Rules and to ensure consistency between State and Federal requirements

**Rule 391-3-24-.07, "Lead Clearance Levels,"** to adopt the updated Federal dust-lead clearance levels for lead abatement into the Georgia Rules and to ensure consistency between State and Federal requirements.

This notice, together with an exact copy of the proposed Lead Rule Amendments, a synopsis, and a statement of rationale of the rule revisions, is being provided to all persons who have requested in writing that they be placed on a notification list. To provide the public an opportunity to comment upon and provide input into the proposed SIP revision, a public hearing will be held at **2:00 p.m. on January 13, 2022**. The meeting is open to the public.
