NOTICE OF PUBLIC HEARING AND PROPOSED AMENDMENTS TO GEORGIA'S RULES FOR SOLID WASTE MANAGEMENT CHAPTER 391-3-4

TO ALL INTERESTED PERSONS AND PARTIES:

Notice is hereby given that, pursuant to the authority set forth below, the Environmental Protection Division (hereinafter, "EPD") of the Georgia Department of Natural Resources proposes amendments to the Georgia Rules for Solid Waste Management, Chapter 391-3-4 (hereinafter, "proposed Rule amendments").

EPD proposes to amend Rules 391-3-4-.01, 391-3-4-.02, 391-3-4-.03, 391-3-4-.04, 391-3-4-.05, 391-3-4-.06, 391-3-4-.07, , 391-3-4-.09, 391-3-4-.12, 391-3-4-.16, and 391-3-4-.19. EPD proposes to amend the Rules by: (1) Revising certain definitions to be consistent with the Georgia Comprehensive Solid Waste Management Act and adding new definitions (391-3-4-.01); (2) Remove requirement for Director to notify legal organ in local jurisdiction when taking action on a permit for a solid waste handling/disposal facility (391-3-4-.03); (3) Adding requirements for mulching operations to help prevent fires (391-3-4-.04); (4) Revise siting criteria to be consistent with the Georgia Comprehensive Solid Waste Management Act (391-3-4-.05); (5) Requirement for certain landfills to submit High Moisture Content Waste management plans (391-3-4-.07); and (6) Deleting references to mulching since section -.04 will cover mulching requirements (391-3-4-.16). Additional clarifications, reference updates, and minor edits are contained in 391-3-4-.02, -.06, -.07, -.09, -.12, and -.19.
