One permit-by-rule application was received for a class 2 composting operation in Dougherty County.

Solid Waste Permitting Unit

The Director issued a permit to Wolf Creek Landfill, LLC, an indirect subsidiary of Waste Management, on May 26, 2022. The permit, # 143-008D(SL), allows for the lateral and vertical expansion of Wolf Creek Municipal Solid Waste Landfill, located near the town of Dry Branch in Twiggs County.

The Director transferred a post closure permit to Covia Clay, LLC from Unimin Corporation on May 26, 2022. The permit, # 158-008D(LI), details post closure performance standards and the remaining post closure care period for the closed private industrial landfill near the town of McIntyre in Wilkinson County.

The Director issued a post closure permit to Georgia Pacific Corporation – Warm Springs Plywood Plant on June 22, 2022. The permit, # 099-017D(LI), details the post closure performance standards and post closure care period for the closed private industrial landfill near Warm Springs in Meriwether County.

The Director issued a permit to International Paper Flint River Mill on June 22, 2022. The permit, # 094-004D(LI), allows for the vertical expansion of the private industrial landfill in addition to finalizing the facility's five-year permit review. The facility is located near the City of Oglethorpe in Macon County.

The Director issued a site suitability notice to the Solid Waste Management Authority of Atkinson County on June 22, 2022. This notice establishes site limitations that will allow for the vertical expansion of the C&D and MSW landfills, permit # 002-009D(MSWL), located near the town of Willacoochee in Atkinson County.

The Director issued a site suitability notice to the Dalton-Whitfield Solid Waste Authority on June 22, 2022. This notice establishes site limitations that will allow for the horizontal and vertical expansion of the Baled Carpet Commercial Industrial Landfill, permit # 155-048D(LI), located near Dalton in Whitfield County.

A draft site suitability letter was issued to EnviCare, LLC for a proposed Transfer Station, Biomedical Waste Treatment, and Materials Recovery Facility located in Cartersville, Bartow County, Georgia on June 22, 2022. Public comments are being accepted on the draft limitations until July 22, 2022.

The Surface Mining Unit received two permit applications on May 31, 2022, from White Oak Timber Properties, LLC to operate the White Oak Mine in Early County, and on June 9, 2022, from Columbus Consolidated Government to operate the Technology Park Parcel 16 Surface Mine in Muscogee County.

The Director approved and issued one surface mining permit (permit # 2097-22) on June 6, 2022, to the City of Jesup to operate a sand mine in Wayne County.
