NOTICE OF PUBLIC HEARING AND PROPOSED STATE PLAN

TO ALL INTERESTED PERSONS AND PARTIES:

Notice is hereby given that, pursuant to the authority set forth below, the Environmental Protection Division (hereinafter, "EPD") of the Georgia Department of Natural Resources proposes a State Plan for Implementation of the Emission Guidelines and Compliance Times for Municipal Solid Waste Landfills. The proposed state plan is described below:

The Georgia Environmental Protection Division (EPD) proposes a State Plan for Implementation of the Emission Guidelines and Compliance Times for Municipal Solid Waste Landfills. The State Plan is to replace the Federal Plan in place based on the 2016 federal emissions guideline for municipal solid waste landfills as required by Section 129 of the Clean Air Act.
