# NOTICE OF NO SIGNIFICANT IMPACT ON THE ENVIRONMENT TO ALL INTERESTED AGENCIES, GROUPS AND PERSONS

The City of Blue Ridge has made an application to the Georgia Department of Natural Resources, Environmental Protection Division (EPD), and the Georgia Environmental Finance Authority (GEFA) for a loan through the State Revolving Fund (SRF). The project consists of the upgrade of a pump station, abandonment of three pump stations, and construction of force main and gravity sewer to transfer flow to the upgraded pump station. The applicant has certified that the project is environmentally sound. As required by the Federal Clean Water Act, an environmental review has been performed on the project described below:

#### **Project Description**

The City of Blue Ridge proposes the upgrade of the Industrial Park Road Pump Station, the abandonment of the Aska #1, Aska #2, and CVS pump stations, and the construction of approximately 4,700 linear feet (LF) of 8" PVC force main, 1,800 LF of 8" PVC gravity sewer, 5,400 LF of 12" PVC gravity sewer, 2,900 LF of 15" PVC gravity sewer, and appurtenant items.

## **Anticipated Impacts**

The proposed project will serve the City of Blue Ridge. The proposed project will eliminate concerns of pump station overflow and failure and provide reliable service to existing customers. It will increase efficiency of the collection system while reducing operating costs.

Minor negative temporary impacts may include noise, dust and erosion/sedimentation associated with construction activities. Best Management Practices will be in place during construction.

The project will take place primarily on City property (or right-of-way) and/or previously disturbed land and no impacts to existing buildings are anticipated as a result of the project.

The current rates for wastewater are not anticipated to be affected as a result of the project.

No anticipated adverse secondary impacts are associated with the project. Consequently, a preliminary decision not to prepare an Environmental Impact Statement has been made.

The reason for the decision not to prepare such a statement is as follows: Project activity is not anticipated to result in adverse environmental impacts beyond those that can be easily mitigated with minimal extra expense or delay in project implementation.

## **Public Notice**

A public information meeting was held on January 6, 2022 at Blue Ridge City Hall to discuss the proposed project. No adverse comments were received during the 30-day advertisement period or during the meeting.

An Environmental Review Record concerning the proposed project has been made by the Georgia Environmental Protection Division that documents the environmental review of the project and provides more detail explaining why an environmental impact statement is not required. The Environmental Review Record is on file at the Division's address listed below. A copy of the SRF planning document is available for public review upon request at Blue Ridge City Hall during business hours and at the Division between the hours of 8:00 a.m. and 4:30 p.m.

No further environmental review of this project is proposed to be conducted prior to the release of loan funds.
