NOTICE OF PUBLIC HEARING AND PROPOSED AMENDMENTS TO GEORGIA'S RULES FOR SAFE DRINKING WATER, CHAPTER 391-3-5

TO ALL INTERESTED PERSONS AND PARTIES:

Notice is hereby given that, pursuant to the authority set forth below, the Environmental Protection Division (hereinafter, "EPD") of the Georgia Department of Natural Resources proposes amendments to the Rules for Safe Drinking Water, Chapter 391-3-5. EPD proposes to amend specific provisions of Rule 391-3-5-.07, "Wells", to provide a procedure for drinking water wells to be located within 100 feet of a surface water. The procedure will require additional water chemistry and bacteriological tests for groundwater wells located within 100 feet of a surface water to assess if the proposed well is under the direct influence of surface water.

This notice, together with an exact copy of the proposed rule amendments, a synopsis, and statement of rationale of the proposed rule amendments, is being provided to all persons who have requested in writing that they be placed on a notification list. The proposed rule amendments are proposed for adoption pursuant to authority contained in the Georgia Safe Drinking Water Act, O.C.G.A. § 12-5-170 et seq.
