## NOTICE OF PUBLIC HEARING AND PROPOSED AMENDMENTS TO GEORGIA'S RULES FOR SAFE DRINKING WATER, CHAPTER 391-3-5

## TO ALL INTERESTED PERSONS AND PARTIES:

Notice is hereby given that, pursuant to the authority set forth below, the Environmental Protection Division (hereinafter, "EPD") of the Georgia Department of Natural Resources proposes amendments to the Rules for Safe Drinking Water, Chapter 391-3-5. EPD proposes to amend specific provisions of Rule 391-3-5-.39, "Public Water Systems Classification", to add a Class IIIG public water system classification to accommodate a new drinking water operator license classification.
