## NOTICE OF PUBLIC HEARING AND PROPOSED AMENDMENTS TO GEORGIA'S RULES FOR Safe Drinking Water, CHAPTER 391-3-5

## TO ALL INTERESTED PERSONS AND PARTIES:

Notice is hereby given that, pursuant to the authority set forth below, the Environmental Protection Division (hereinafter, "EPD") of the Georgia Department of Natural Resources proposes amendments to the Rules for Safe Drinking Water, Chapter 391-3-5. EPD proposes to amend specific provisions of Rule 391-3-5-.25 "Treatment Techniques, Lead and Copper Requirements", to add paragraph to require all water systems to conduct and electronically report their lead service line inventories by October 16, 2024; and to update the format of references to the Code of Federal Regulations (CFR).

This notice, together with an exact copy of the proposed rule amendments, a synopsis, and statement of rationale of the proposed rule amendments, is being provided to all persons who have requested in writing that they be placed on a notification list. The proposed rule amendments are proposed for adoption pursuant to authority contained in the Georgia Safe Drinking Water Act, O.C.G.A. § 12-5-170 et seq.
