Description of Requested Modification/Change: SNF- Riceboro proposes to re-permit the Flocryl Acrylates AD6 Batch Plant as a continuous plant, the Flocryl AcrylatesAD6 Continuous Plant (AD6 plant). In addition the facility proposes to modify equipment at the AD6 plant.
