**Emission Increase/Decrease:** The proposed change will increase emissions of NOx by approximately 17.93 tons per year (tpy); emissions of PM by approximately 22.63 tpy; PM less than 10 microns in diameter (PM10) by approximately 14.79 tpy; PM less than 2.5 microns in diameter (PM2.5) by approximately 8.54 tpy; sulfur dioxide (SO2) by 4.38 tpy; volatile organic compounds (VOC) by approximately 240.8 tpy; carbon monoxide (CO) by approximately 44.57 tpy; individual hazardous air pollutant (HAP) by approximately 9.66 tpy; total HAPs by approximately 19.53 tpy; and greenhouse gases by approximately 36,855 tpy.

**Description of Requested Modification/Change:** Requests extension of the deadline to commence construction from January 17, 2023 for another 18 months and authorization to combust natural gas in proposed continuous kiln OSK4 (in addition to wood).
