NOTICE OF THE PROPOSED REISSUANCE OF NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMITS FOR DISCHARGES FROM PHASE I MEDIUM MUNICIPAL SEPARATE STORM SEWER SYSTEMS (MS4s) TO THE WATERS OF THE STATE OF GEORGIA.

The Georgia Environmental Protection Division (EPD) is considering the reissuance of the following Phase I Medium MS4 permits, authorizing stormwater discharges from municipal separate storm sewer systems (MS4s) to the waters of the State of Georgia. The permits will require implementation of a stormwater management program summarizing the activities to be used by the permittee to reduce pollutants to the maximum extent practicable.
