Description and Location of Proposed Activity: <u>Georgia Department of Transportation Project (GDOT) PI No.</u> 0013987 is a roadway widening project at Lake Park Bellville Road from the Interstate 75 interchange to State Route 7/United States Highway 41 in Lake Park, Georgia. The project will disturb 1,334.71 square feet of the Open Water 6 buffer. All disturbed land will be revegetated with a native riparian grass seed mixture per GDOT's Standard Specification 700.
