- The Director issued a CCR Permit to Georgia Power Company on June 18, 2021. The permit number 063-030D(CCR), allows Georgia Power to close Plant McManus AP-1 in Glynn County via the closure-by-removal provisions of the rules.

Surface Mining Unit

- The Surface Mining Unit received one permit application on May 26, 2021, Camden County to permit a surface mine in Camden County.
- The Director approved and issued two surface mining permits: 2081-21 was issued on June 4, 2021, to Anguilla Acres LLP to operate a sand pit in Glynn County, and 2083-21 was issued on June 3, 2021, to Thiele Kaolin Company to operate a kaolin mine in Washington County.
- The Surface Mining Unit continued to work with a Permit Coordination team with Twin Pines Minerals (TPM) application and provided comments on April 13, 2021. A meeting was held with TPM consultants on June 24, 2021. Partial response to comments was received from TPM on June 25, 2021.
