- The Director issued a Site Suitability Notice on April 30, 2021, for a proposed solidification facility in Lowndes County to be operated by Georgia Petroleum, Inc.
- A notice of intent to issue a CCR permit, relating to the closure by removal of Georgia Power's Plant McManus AP-1, was posted on the Land Public Announcements webpage on May 5, 2021. The public comment period extends through June 4, 2021, and a final permit is anticipated to be recommended to the Director once comments are addressed.
- The Solid Waste Permitting Unit received an application for a solid waste handling permit on May 25, 2021, from Dixon Airline Recycling and Disposal, LLC for a proposed C&D landfill and MRF in Richmond County, City of Augusta.
