Solid Waste Permitting Unit

- A permit application was received on March 9, 2022, for a proposed inert landfill in Brunswick, Glynn County, Georgia to be owned and operated by Plant Improvement Company Inc., DBA Seaboard Construction Company.
- A permit application was received on March 11, 2022, for a horizontal expansion of the Spalding County – Griffin Shoal Creek C&D landfill.
- A response to comments, issued on January 13, 2022, was received on March 3rd for the Coastal Terrace Solid Waste Handling Facility in Brantley County. Review of the response is ongoing and additional comments or D&O plan approval is anticipated in early April.
- Comments were issued on March 3, 2022, regarding the closure plan of Plant Shearer AP-1 CCR Surface Impoundment.
- A second meeting was held on March 25, 2022, with representatives of EPA Region 4 and Headquarters regarding technical questions about the proposed closure in place permit at Plant Hammond AP-3, near Rome.
- A meeting was held on March 15, 2022, with representatives from Crisp County Power Commission and their consultants regarding two areas of CCR discovered post permit issuance. It was determined that the most appropriate course of action would be a major modification to the existing permit for the closure by removal of the newly discovered waste areas.
