Description and Location of Proposed Activity:

The applicant proposes to impact 71 linear feet (921 ft²) of stream buffer along the Camp Bert Adams Creek to grout and fill an 8"DIP sanitary sewer pipe that is in disrepair. Additionally, two bore holes will be drilled on either side of the creek for installation of a new 8" sanitary sewer line to be installed outside the buffer. Upon completion of land-disturbance, the stream buffer will be returned to pre-existing conditions as much as is practicable. The project is located on Sports Ave. off of Spring Rd. in the City of Smyrna.
