This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(A-K)}: A

Description and Location of Proposed Activity:

The applicant proposes to impact 304 linear feet (7,925 ft²) of stream buffer along an unnamed tributary that flows to the Etowah River to install a 4-foot high, 10-foot wide berm to control flooding of recreational sports fields along the edge of Rock Creek Park. Upon completion of land-disturbance, the newly constructed berm in the stream buffer will be replanted with a native canopy of riparian species. The project is located at Rock Creek Park one mile from the intersection of Dawson Forest Rd. and Hwy. 9 in unincorporated Dawson County.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
