Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(A-K)}: H

Description and Location of Proposed Activity:

Applicant proposes to permanently impact 1,220 linear feet (67,135 ft<sup>2</sup>) of stream and buffer along two unnamed tributaries of Big Branch Creek to construct two Industrial Warehouses and associated infrastructure. Upon completion of land-disturbance, the project will contain two post-construction stormwater ponds and a proprietary device to filter pollutants of concern. The project is located on South Fulton Parkway 4.6 miles from the GA-14 Spur with South Fulton Parkway.
