This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(A-K)}: A

Description and Location of Proposed Activity:

Applicant proposes to impact 95 linear feet (1,427 ft²) of stream buffer in three separate areas along an intermittent tributary to Tanyard Branch. The slope within the stream buffer will be repaired by construction of a Filtrex Living Wall. Compost socks are filled and installed along the affected area, then built up to stabilize and repair the unstable slope. The Filtrex wall include geogrid reinforcement between each Filtrex sock. Re-vegetation along the buffer will include species of Silky Dogwood, Mountain Laurel, Piedmont Azalea, and Wild Hydrangea. Project is located at 860 Meredith Dr. within the city limits of Atlanta.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
