Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(A-K)}: B & F

Description and Location of Proposed Activity:

Applicant proposes to impact 950 linear feet (48,900 ft<sup>2</sup>) of stream buffer along an unnamed tributary to the Chattahoochee River to construct connector trails to provide pedestrian access and recreation within the Peachtree Corners area. The project also proposes to improve the stream water quality by constructing instream riffle pool sequences, rock cross vanes and rock toe protection. The project is on Peachtree Parkway 2.7-mi. from the intersection of Peachtree Parkway and Peachtree Industrial Blvd.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
