Description and Location of Proposed Activity:

This project will result in the construction of a senior living center on approximately 11 acres along Maple View Drive in Carrollton. The design was created to minimize disturbance while providing necessary access points to support the future residents. This project will include an on-site stormwater management system (including a wet stormwater pond, matted slopes, storm sewers with outlet protection and permanent grasses). The proposed project will result in 537 linear feet of buffer impacts (32,135 ft²) along an unnamed tributary of Little Tallapoosa River in the Upper Tallapoosa Watershed.
