Description and Location of Proposed Activity:

This project will develop 3.54 acres of property into a mixed-use development containing retail, office, hotel, and residential spaces. The buffer disturbance will replace an old open water detention pond with underground stormwater detention vaults and a proprietary water quality device. The proposed project will result in 278 total linear feet (17,923 total square feet) of buffer disturbance lasting between 18 and 24 months located near an unnamed tributary to Rottenwood Creek in the Upper Chattahoochee Watershed.
