Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Description and Location of Proposed Activity:

Applicant proposes to impact a total of 460 linear feet (8,921 square feet) of stream buffer associated with the construction of multi-use pedestrian trail. The plan was designed with minimal buffer disturbance in mind; however, there are unavoidable areas of buffer disturbance due to existing property lines and topography. After construction the streambank will be stabilized with multi-trophic native riparian vegetation placed in all practicable locations. The project lies within the Middle Chattahoochee Watershed (03130002).
