Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Description and Location of Proposed Activity:

The applicant proposes to impact 100 linear feet (2,500 square feet) of shoreline buffer along Lake Redwine to construct a 3-ft. high, 6-in. wide retaining wall constructed of wood pilings and planks to control ongoing erosion and protect private property. The applicant will revegetate the buffer with multi-trophic vegetation in accordance with EPD's Streambank and Shoreline Stabilization Guidance Document. The project is located at Lot 73 Northshore at Lake Redwine on Waterview Ct.

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
