Description and Location of Proposed Activity:

This project will develop 23 acres of property into a distribution center with supporting infrastructure. The buffer disturbance will pipe and fill an intermittent stream and include post construction stormwater controls. The proposed project will result in 340 total linear feet (16,727 total square feet) of buffer disturbance lasting 12 months located at an unnamed intermittent stream to Gothards Creek in the Middle Chattahoochee Watershed (03130002).
