This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (b) & (f)

Description and Location of Proposed Activity:

This project will expand a recreational foot trail from Connally Park to Sumner Park. The trail will be comprised of concrete, compacted earth, and wood, depending on the portion of the trail. The design includes two footbridges and one boardwalk area in the buffer, all wooden. BMPs during construction include silt fencing, mulching, dust control, temporary and permanent plantings, and tree protection. The plans include a permanent bioslope trench as well as planting 5,100 square feet of native riparian vegetation along the bank, which will improve habitat and water quality. The proposed project will result in 602 total linear feet (10,142 total ft²) of buffer disturbance lasting approximately 3 months. The project is located at an unnamed tributary to South Utoy Creek, in the Middle Chattahoochee Watershed.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
