Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Description and Location of Proposed Activity:

This project will restore and stabilize a streambank to ensure the safety of the adjacent roadway and private driveway. Measures to ensure long term stability include Flexmat a woven concrete block matting, with additional bioengineering practices. Vegetative measures include permanent seeding, and natural vegetation. The proposed project will result in 396 linear feet (7,867 ft²) of buffer disturbance lasting between 2-3 months. The project is located at Long Island Creek in the Upper Chattahoochee Watershed (03130001).
