Description and Location of Proposed Activity:

This project will convert an existing golf course to landscaped walkways for a future apartment complex on a 22.47-acre site. The buffer will be disturbed due to landscaping to occur on a small island within a pond on the site. After construction is complete, the buffer will be replanted with native multi-trophic vegetation. The proposed project will result in 247 linear feet (4,911 ft²) of buffer disturbance lasting approximately 60 days located at an unnamed pond upstream from to Sweetwater Creek in the Upper Ocmulgee Watershed.
