Description and Location of Proposed Activity:

This project will construct a warehouse facility and associated infrastructure on 41.04-acres. The site was designed with minimal disturbance in mind. After construction is complete, a micropool and stormwater pond will protect downstream water quality. The proposed project will result in 500 linear feet (32,668 ft²) of buffer disturbance lasting approximately 1 year located at an unnamed tributary of Indian Creek in the Upper Ocmulgee Watershed.
