Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

This project will modify an existing pond on the property to act as a post-construction stormwater detention pond for a proposed subdivision. Removal of accumulated materials from the pond will increase volumetric storage capacity and ensure an improvement to water quality. The buffer of the pond will be replanted with native herbaceous vegetation and grasses. The proposed project will result in 938 linear feet (23,453 total ft²) of buffer disturbance lasting between 12 – 20 weeks located near the intersection of Lake Dow Road and McGarity Road, at an unnamed tributary to Kalves Creek in the Upper Ocmulgee Watershed.
