This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The applicant proposes to disturb 9.7 acres to construct a new pipeline for an NPDES treated wastewater outfall. The pipe will be placed 3 feet under the existing grade. The design of this project includes 2 areas which require buffer variance: one stream crossing and one outfall area. BMPs during construction include rock filter dams, temporary diversion berms, sediment barriers, and mulching. Permanent BMPs include native grasses and a riprap apron at the outfall site. Impacts to the stream were kept to a minimum during the design process. The applicant will purchase a total of 1.5 wetland credits and 34 stream credits for mitigation. The proposed project will result in approximately 133 total linear feet (1,882 total square feet) of buffer disturbance lasting approximately 4 months located at Buffalo Creek and an unnamed tributary to Keg Creek, off Pipeline Road and Yank Brown Road, in the Lower Oconee Watershed.

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
