**I. NOTICE OF AN APPLICATION FOR A NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT TO DISCHARGE TREATED WASTEWATER INTO WATERS OF THE STATE OF GEORGIA**

NPDES permits are valid for a maximum of five years. Prior to expiration of an existing permit, a new application must be submitted and evaluated.

An antidegradation analysis is conducted, as applicable, for new or expanded point source discharges that are proposed. The analysis evaluates whether allowing lower water quality is necessary to accommodate important economic or social development in the area in which the waters are located. In all cases, existing instream water uses and the level of water quality necessary to protect the existing use is maintained and protected.

All municipalities must be in compliance with the Georgia Department of Community Affairs (DCA) Service Delivery Strategy in order to receive a permit.

Having reviewed such applications, the Environmental Protection Division (EPD) is considering the issuance of NPDES permits to the following applicants, subject to specific pollutant limitations and special conditions.

**NPDES PERMIT REISSUANCE**

**Bartow County**

YMCA of Metropolitan Atlanta, 101 Marietta Street NW Suite 1100, Atlanta, GA 30303, NPDES Permit No. GA0027456, for the Lake Allatoona Recreational Facility Water Pollution Control Plant located at 40 Old Sandtown Road SE, Cartersville, GA 30121. Up to 0.025 MGD of treated wastewater is being discharged to Lake Allatoona in the Coosa River Basin.

**Early County**

City of Blakely, Post Office Box 350, Blakely, Georgia 39823, NPDES Permit No. GA0025585, for the Blakely Water Pollution Control Plant located at Plant Street, Blakely, Georgia 39823. Up to 2 MGD of treated wastewater is being discharged to Baptist Branch in the Flint River Basin.

**Gwinnett County**

City of Buford, 2300 Buford Hwy, Buford, Georgia 30518, NPDES Permit No. GA0023167, for the Southside Water Pollution Control Plant located at 1201 Chatham Road, Buford, Georgia 30518. Up to 2.0 MGD of treated wastewater is being discharged to the Suwanee Creek in the Chattahoochee River Basin. The permit also includes effluent limitations and monitoring requirements for the expanded flow of 3.0 MGD.

**Marion County**

City of Buena Vista, P.O. Box 158, Buena Vista, Georgia 31803, NPDES Permit No. GA0023710, for the Buena Vista Water Pollution Control Plant located at Burkhalter Avenue, Buena Vista, Georgia 31803. Up to 0.50 MGD of treated wastewater is being discharged to an unnamed tributary of Oochee Creek in the Flint River Basin.

Up to 0.25 MGD of treated wastewater is being discharged to Kennel Creek in the Flint River Basin.

In the case of the Industrial Pretreatment Program Approvals and Modifications comments are to be submitted to EPD no later than **August 13, 2019**.
