Type of Permit Application: Variance to encroach within the 50-foot State waters buffer.

Description and Location of Proposed Activity:

This project will replace existing gravity sewer and upgrade a lift station to serve existing business and to allow for future properties to access the sanitary sewer line. Three separate buffer intrusions are necessary due to existing easements, topography, and stream locations. After construction is complete the buffer will be restored to its current existing condition with vegetative measures. The proposed project will result in 550 total linear feet (13,075 total ft²) of buffer disturbance lasting approximately 3 months and located on Weaver Creek in the Oconee Watershed (06020003).

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
