Type of Permit Application: Variance to encroach within the 50-foot State waters buffer.

Description and Location of Proposed Activity:

This project will create flatter slopes on both sides of the creek that has been experiencing erosion and has compromised structures owned by the applicant. Once complete the native riparian vegetation will minimize erosion and reduce runoff by reestablishing a buffer denuded of canopy, vegetation, and shading. The proposed project will result in approximately 401 linear feet (4,894 ft²) of buffer disturbance lasting approximately 1 month and is located near Shoal Creek in the Upper Chattahoochee Watershed (03130001).
