Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Basis under which variance shall be considered {391-3-7.05 (2)(A-K)}: H

Description and Location of Proposed Activity:

Applicant proposes to permanently impact 220 linear feet (12,186 ft<sup>2</sup>) of a tributary to Peavine Creek to construct 85 multi-family apartments and associated infrastructure on a 3.8-acre site. The stream will be re-routed into a 96-inch reinforced concrete pipe in order to provide sufficient space for development. The project is located at the roundabout with North Decatur Rd. and Lullwater Rd.
