## <u>Tributary to Little Pine Knot Creek/Streambank Restoration</u> Activity

This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(A-K)}: \_\_\_B

Description and Location of Proposed Activity:

The applicant proposes to impact 420 linear feet (28,399 ft²) of stream buffer along a tributary to Little Pine Knot Creek to perform stream restoration measures located below the outfall of a pond with a dam breach. The existing stream will be backfilled for 350 and a new channel created northwest of the end of the dam will connect to the existing channel downstream of the backfill. Stream restoration will utilize natural channel design and sinuosity. In-stream features include a total of 21 log, rock vane and toe-wood structures. Upon completion of land-disturbance, the buffer will be replanted with a canopy of native riparian species. The project is located on the Pine Knot Tract approx. 13 miles west from the intersection of the Pine Knot Tract and SR355 in Marion County.

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
