Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(A-K)}: D

Description and Location of Proposed Activity:

Applicant proposes to impact 1,498 linear feet (15,475 ft²) of stream buffer along the Alcovy River and two unnamed tributaries to install a 12" PVC and 12" Ductile Iron & 18" PVC and 18" Ductile Iron" sanitary sewer line with associated manholes to increase sanitary sewer service for the City of Monroe. The project begins at the Alcovy River Outfall S.R. 138 and ends at Reliant Pump Station.

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
