Description and Location of Proposed Activity:

Applicant proposes to impact 163 linear feet (650 ft²) of stream buffer along the bank of Lake Blackshear to construct a concrete retaining wall to prevent ongoing erosion of private property due to wave action from recreational watercraft. Upon completion of the project, 75% of the feature will be replanted with prairie cordgrass, (Spartina Pectinata), "Big Bluestem" (Andropogen Gerardii), "Switchgrass" (Panicum Virgatum) and/or "Pink/White Muhly Grass" (Muhlenbergia Capillaris), and two Cypress trees. Project is located on Smoak Bridge Circle in unincorporated Worth County.
