I. NOTICE OF AN APPLICATION FOR A NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT TO DISCHARGE TREATED WASTEWATER INTO WATERS OF THE STATE OF GEORGIA

NPDES permits are valid for a maximum of five years. Prior to expiration of an existing permit, a new application must be submitted and evaluated.

An antidegradation analysis is conducted, as applicable, for new or expanded point source discharges that are proposed. The analysis evaluates whether allowing lower water quality is necessary to accommodate important economic or social development in the area in which the waters are located. In all cases, existing instream water uses and the level of water quality necessary to protect the existing use is maintained and protected.

All municipalities must be in compliance with the Georgia Department of Community Affairs (DCA) Service Delivery Strategy in order to receive a permit.

Having reviewed such applications, the Environmental Protection Division (EPD) is considering the issuance of NPDES permits to the following applicants, subject to specific pollutant limitations and special conditions.

NPDES PERMIT REISSUANCE

Camden County

River Oaks Mobile Home Park, 30 Crooked River Drive, Woodbine, GA 31564, NPDES Permit No. GA0035599, for the River Oaks Mobile Home Park Water Pollution Control Plant located at 7470 Harriett's Bluff Road, Woodbine, Georgia 31564. Up to 0.008 MGD of treated wastewater is being discharged to an unnamed tributary of the Crooked River in the St. Marys River Basin.

Early County

Republic Conduit, Inc., 633 Georgia Tubing Road, Cedar Springs, Georgia 39832, NPDES Permit No. GA0000230, for its coated steel tubing manufacturing facility located at 633 Georgia Tubing Road, Cedar Springs, Georgia 39832 in Early County. A maximum of 0.57 MGD of metal finishing process wastewater, non-contact cooling water, and stormwater is discharged to the Chattahoochee River in the Chattahoochee River Basin.

Taliaferro County

City of Crawfordville, Post Office Box 8, Crawfordville, Georgia 30631, NPDES Permit No. GA0020915, for the Crawfordville Water Pollution Control Plant located at 603 Jennings Street, Crawfordville, Georgia 30631. Up to 0.1 MGD of treated wastewater is being discharged to an unnamed tributary of Mile Branch in the Ogeechee River Basin.

White County

SRM Materials, LLC, 1136 2nd Avenue North, Nashville, Tennessee 37208, NPDES Permit No. GA0046302, for its granite quarry facility located at Long Mountain Resources, 3489 Highway 115 W Cleveland, Georgia 30528 in White County. A maximum of 11.63 MGD of crushed granite wastewater commingled with stormwater is discharged to unnamed tributaries to Shoal Creek in the Chattahoochee River Basin.

II. NOTICE OF AN APPLICATION FOR AN INDUSTRIAL PRETREATMENT PERMITS TO DISCHARGE WASTEWATER TO A PUBLICLY OWNED TREATMENT WORKS.

Industrial Pretreatment permits are valid for a maximum of five years. Prior to expiration of an existing permit, a new application must be submitted and evaluated.

INDUSTRIAL PRETREATMENT PERMIT REISSUANCE

Chatham County

Total Clean, LLC, 5500 HWY 80 West, Jackson, Mississippi 39209, Pretreatment Permit No. GAP050134, for its tank trailers cleaning facility located at 6053 Commerce Court, Garden City, Georgia 31408 in Chatham County. A maximum of 0.010 MGD of transportation equipment cleaning (TEC) process wastewater is discharged to the Garden City Water Pollution Control Plant's sewerage system in the Savannah River Basin.

III. NOTICE OF AN APPLICATION FOR A LAND APPLICATION SYSTEM PERMIT FOR THE DISPOSAL OF WASTEWATER APPLIED TO THE SURFACE OR BENEATH THE SURFACE OF LAND.

Land Application System (LAS) permits are valid for a maximum of five years. Prior to expiration of an existing permit, a new application must be submitted and evaluated.

All municipalities must be in compliance with the Georgia Department of Community Affairs (DCA) Service Delivery Strategy in order to receive a permit.

LAS PERMIT REISSUANCE

Liberty County

United States Army, Fort Stewart, 1550 Veterans Parkway Fort Stewart, GA 31314, Permit No. GAJ030834 for a sewage waste treatment facility located at Wright Army Airfield in Liberty County. A maximum of 0.01 MGD of pretreated sanitary waste will be land applied to a dedicated site in the Ogeechee River Basin.

LAS PERMIT MODIFICATION

Coweta County

Twelve Parks Sewer, LLC, 475 Swanson Road, Tyrone, Georgia 30290, LAS Permit No. GAJ040034, for the Twelve Parks Water Pollution Control Plant located at McIntosh Trail, Sharpsburg, Georgia 30276. The facility land applies treated domestic wastewater on a dedicated site in Coweta County in the Flint River Basin. The permit is being modified to include a reduced flow of 0.08075 MGD and a reduced wetted area of 11.55 acres for Phase I.

In the case of the Industrial Pretreatment Program Approvals and Modifications comments are to be submitted to EPD no later than **July 14, 2020**.
